Application for Membership

Dear applicant:

Thank you for your interest in our organization. Prior to filling out the attached application for membership, there are a few things you should know about the process.

Hudson Valley Hornets Inc. is a private, member- owned and operated organization. We are a non-profit educational organization. In our Constitution, Article 3, Section 1 states " The objects, purpose and scope of this club shall be: (a) to establish a social and recreational club. (b) to promote, sponsor, manage, handle and direct all activities in connection with aviation; primarily including, but not limited to, light aircraft, ultra lights, and home built aircraft. To sponsor fellowship among members of the Club"

Candidates presenting themselves for membership in the Hudson Valley Hornets, Inc are evaluated for sixty days in order that the club may assure itself of a good "fit". In a similar fashion, candidates can evaluate the Club during the same time frame.

The Club is interested in the candidate's motive for joining, expectations, understanding of and commitment to Club work efforts and projects, the level and quality of interaction with fellow Club members, and appreciation of the Club's culture as per the constitution.

Therefore the following process will apply to your application:

1. You will complete the attached application and submit it with your check for the desired level of Membership.
2. The Executive Board will review your application. If you are approved , they will invite you to Join Hudson Valley Hornets as a "Provisional member" for the first 60 days.
3. The Executive Board will direct the Treasurer to hold your check for 60 days.
4. If for any reason during this 60 day period you decide you don't want to continue your membership , your uncashed check will be returned to you in full.
5. Concurrent with your evaluation of us, the Executive Board will, with input from the membership, evaluate your fit as outlined above.
6. When the provisional period is at an end, your requested level of membership becomes Permanent, your check will be deposited by the Club, and both you and the Club will have had the opportunity to make an informed decision.
7. Memberships are not transferable. Membership fees, including any later upgrades, are not refundable after the initial sixty (60) day period.
